### 4. First Aid Measures

#### 4.1 Description of first aid measures

**Eye Contact:** If eye irritation from exposure to vapors develops, move to fresh air. Flush eyes with clean water. If irritation persists, seek medical attention. For direct eye contact, flush with large quantity of water for 15 minutes. Seek medical attention.

**Skin Contact:** Remove contaminated clothing; flush skin thoroughly with water. If irritation occurs, seek medical attention.

**Inhalation (Breathing):** If irritation of nose or throat develops, move to fresh air. If irritation persists, seek medical attention. If breathing is difficult, provide oxygen. If not breathing, give artificial respiration. Seek immediate medical attention.

**Ingestion (Swallowing):** Ingestion of small amounts of this material is not likely to be harmful. Ingestion of large quantities may cause irritation of the digestive tract and/or nervous system depression (e.g., drowsiness, dizziness, loss of coordination, and fatigue). This is an unlikely route of exposure in towelette package.

Do not get in eyes, on skin, or on clothing. Do not eat, drink or smoke when using this product. Wash thoroughly after handling. Wash contaminated clothing before reuse. Use only outdoors or in a well-ventilated area. For industrial or professional use only.
